## **MEMORANDUM OF UNDERSTANDING**

Here after the first party shown in the documents as ASTC.

### **AND**

**DATAPRO Computers Pvt ltd. second party** and represented herein by its Center manager, **KRISHNA CHAITANYA.B** (hereinafter referred to as “**Second Party**”, company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

### **WHEREAS:**

- G) NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

### **General Agreement**

- H) In order to facilitate in-House training on technical advancements, to acquaint the knowledge by students & Staff with updated technologies in Engineering in the areas of Mechanical, EEE,ECE,& CSE, this agreement is executed. Here after AVANTHI's ST.THERESSA INSTITUTE OF ENGG & TECHNOLOGY, addressed as ASTC and DATAPRO Computers Pvt Limited. addressed as DATAPRO, both agree to establish this memorandum of understanding (MOU) as a framework for cooperative programs.

### **ARTICLE-1 Student Training**

It is agreed that DATAPRO will support students of ASTC to provide the training in the advanced courses as and when required. Timing and other details will be as per the mutual acceptance to both the institutions.DATAPRO will be charge nominal fee as per the courses offered. and it will be finalized as per the discussions at the time of organizing the programme DATAPRO COMPUTERS PVT,LIMITED has excellent infrastructure and qualified trainers man power to impart skill training for mechanical ,EEE,ECE& CSE.

### **ARTICLE –II Course: Seminars, Workshops .refreshers Courses**

It is agreed that ASTC arranged the periodic seminars. Workshops and refresher courses in collaborate with DATAPRO Experts from DATAPRO as well as faculty from ASTC With significant exposure in the topic of interest will coordinate and conduct these course ASTC arrangements for such courses will be made by ASTC in keeping with the convenience of experts from DATAPRO. Purpose, timings and other details concerning the course shall be mutually acceptable to both the institutions. it is agreed that information concerning the duration of the visit. The proposed topics of the course and any further details , as required will be

mutually discussed by ASTC with DATAPRO. By ASTC, the intimation will be given to Data pro at least one month prior to the schedule of the course or workshop.

### **Article-III**

#### **Cooperative Research**

It is Anticipated that significant opportunities, of which a few have been identified exists for cooperative research between ASTC and DATAPRO. Such clearly benefits activities may require specify arrangements .In view of the importance of cooperative research , DATAPRO will provide necessary support to visiting faculty from ASTC to study research problems at Data pro, such problems will be analogized and solutions suggested by the ASTC may be necessary and of use to either party.

### **ARTICLE –IV**

#### **Duration of Memorandum of under standings**

The effective date of this MOU shall be 1<sup>st</sup> Sep-2021, The MOU shall extend for a period of a (Five) years and may be renewed upon mutual written agreement. The MOU may be modified by mutual written agreement. The MOU may be terminated by either DATAPRO or by ASTC with notified to the other party six months prior to the effective date of termination.
